#### **1. SCOPE OF WORKS**

#### 1. DURATION OF THE CONTRACT

The duration of the contract shall be discussed with the appointed services provider which may not exceed 12 months:

#### 2. Specification:

#### Reporting directly to the Principal / his delegate, the appointed service provider will be expected to:

- 1. Supply and installation of a dedicated internet connection service via Fiber Optic Cable.
- 2. Fiber Optic connection or stable Wireless Radio link internet connection with capabilities of 100 Mbps.
- 3. The solution should have primary fibre links and wireless fail over capabilities that will ensure 100 % uptime of connectivity.
- 4. The solution should make provision of linking the server room and the point of entry providing the internet connection via Fibre Optic connectivity.
- 5. At least 99.5 % service availability in both uptime and downtime.
- 6. Provide customer service support (on-call and on-site) 24/7 including holidays.
- 7. Provide single point of contact for customer support in both areas of network connectivity and Internet access.
- Four (4)-hour response time for technical problem that requires on-site services for problem reported before 1:00 PM.
   For problems reported after 1 PM, services shall be rendered 8:00 AM of the following work day. Work during weekends and holiday may be allowed subject to the approval of the principal.
- 9. The ISP shall confirm in writing any report service interruption due to INTERNET SERVICE PROVIDER's equipment or facilities or causes within its control, and adjust or repay part of the charges in accordance with a rebate structure.
- 10. The ISP must be aware that in-house technicians will be responsible for maintenance and management of all on-site equipment (network devices).
